From the initial reminder through checking back with writers, proofing, layout and delivery, our issues of Twigs magically appear month after month. An enormous Thank You to Kathy and her team.

We are experiencing the strength of women across the country. More than 70% of newly registered voters in Kansas were women. The pattern continued in Idaho, Wisconsin, Louisiana, Pennsylvania, Alaska, Ohio, Missouri, and Colorado. Thank you to the Supreme Court of the United States; your decision galvanized us.

Dr. Steven Macek, a professor of communications and Department Chair of Communications and Media Studies at North Central College gave a provocative presentation Citizens United, Dark Money and Gender Equity on October 5 at the Glen Ellyn Civic Center. Dr. Macek showed the decline of women in the computing workforce from 1948 when half of the math department at Bell Labs were women to the present when only 26% of computer related jobs are held by women. Two key points were: (1) Gender equity must be specifically programmed into Artificial Intelligence and (2) Companies should be incentivized to hire women for technology positions.

As we approach Thanksgiving, we thank all of you for your friendship, support, hard work and esprit de corps that keep our Branch afloat. It is not too early to make plans for attending the 2023 AAUW-IL State Convention, Friday and Saturday, May 5 and 6, 2023 in Peoria. Go to the AAUW-IL website for more information and to register. The Branch has a Convention and Leadership Fund to help with expenses for members attending the convention. We should be able to fund the two Co-Presidents and four additional Board members. Pamela received her first summer internship to work for the Newburgh (NY) Evening News, working as a reporter and photographer where she learned about the news business, while gathering byline stories and having her photography published on a regular basis. After graduating, Pamela won a one-year internship as a general assignment reporter for the Minneapolis Tribune, now renamed the Star-Tribune. She spent a year working for the Minnesota Spokesman-Recorder Newspapers, an African-American weekly publication, writing articles that appeared in the news, entertainment, environment, and arts sections. Upon her move back home to Chicago, Pamela taught second and third grade students at the Ray School in Hyde Park. After teaching at the National Teacher's Academy, and working as a Mathematics Editor for the McGraw-Hill Companies, Pamela worked at the University of Chicago in the University's Physical Sciences and Biological Sciences Divisions.

With her wide and varied background, she found her true interest in the Finance and Education fields. Pamela took a position in the Finance Section at Fermi National Accelerator Laboratory, which she counts as the most stimulating work that she had in her working career.

On a personal level Pamela has a strong interest in researching the roles of her mother and grandmother, Elsie Mae Freeman and Julia Elaine Freeman, African American women who worked as chemistry laboratory assistants in the Metallurgical Division in Chicago of Manhattan Project during World War II. Often overlooked, their history and others are now stored at the Atomic Heritage Foundation's National Museum of Nuclear Science and Science in New Mexico.

As a new student to the University of Chicago, Pamela looks forward to completing an MBA degree and continue in a career in financial management.

The Board met on October 12. After the minutes of that meeting are approved by the Board at the November 9 Board Meeting, they will be available on the Branch Website Members Only web page. Details of topics discussed are described in the reports from Officers and Chairs elsewhere in this newsletter.

There were two motions approved at that meeting.

- 1. It was moved that the Branch change the name of its Branch Gender Equity Fund (previously the Educational Opportunities Fund) to the Opportunities Fund, so named because such funds are reserved for funding educational and other opportunities for women and girls. The motion was unanimously approved.
- 2. Policy Handbook Chair Palmer presented final changes to the 2022 update of the Policy Handbook. The motion to accept the final draft was unanimously approved.

Policy Handbook: Every five years or so, the Branch reviews the Policy Handbook and updates it as needed (most recent update was 2016). The Policy Handbook includes the Branch policies, guidelines and job descriptions that help the Branch operate consistently from year to year. The 2022 update added some new items, such as, the Zoom Policy and the LUNAFEST Fundraiser. It also removed some items that are no longer part of Branch activities, such as, the neighborhood assignments and the Eleanor Roosevelt and Legal Advocacy Funds. There were also many areas where wording was updated to reflect activities and responsibilities that are being handled electronically instead of by mail or distribution of paper copies. The Policy Handbook does not have the effect of Bylaws but is especially useful to officers, committee chairs and coordinators and to new members. It is available on the Members Only page of the website.

Harnack was seized and convicted to prison in 1942, but Hitler ordered her execution. Harnack's letter home to Milwaukee forms the basis of this enthralling and unusual story.
