CALL TO ORDER:

APPROVAL OF MINUTES:

- The Co-Presidents plan to streamline the monthly branch business meetings and encourage members to read reports in Twigs.

OFFICER REPORTS:

Treasurer:

- A proposed budget meeting was held on August 26. This did not leave the treasurer enough time to prepare the document.
- A plan to alter the months for presentation of the proposed budget will be investigated.
- A successful audit of the branch finances has been completed. The report will be added to the branch records.

Membership Vice President:

- The Membership Vice Presidents are working on the membership roster for 2024-2025. They are working with the Treasurer to confirm the list. There are 123 members with six outstanding to confirm.
- There is a two-month grace period for payment.
- The branch has a Dues Assistance Fund if any member needs it.

Program Vice President Report:

- Programs for 2024-2025 are in place for most of the year. See the Twigs issue for details of the extensive list being planned.
- The September meeting will have an AAUW Fellowship recipient as a speaker.
- The September meeting will also showcase Interest Groups with details of their plans.
- Members will be encouraged to bring their own beverages in recyclable containers to future meetings.

COMMITTEE REPORTS

Book Sale

- The Opportunity Fund will receive over 14,000 dollars from the sale.

- Knowledge Discovery and Scarce took all the leftover books.

Fund Raising Walk

The fund-raising walk announcement was made by Carolyn Oesterle.

The event will take place on September 20, 9 am, at Hidden Lake. It will be about a two-mile walk. There will be a trivia contest prepared by Patricia Spence. The park district shelter will be used as part of the event. Members can sign up at the September branch meeting.

Public Policy

- Voting in DuPage County begins on September 28 at the Du Page County Fairgrounds. There will be other early voting locations announced in October.
- Voter Guides for candidates are online, including National.
- Title IX will need the support of Congress to update changes that are on hold for now.
- Illinois AAUW Connections will have information about proposed issues. Three bills concerning reproductive rights are included.

Stem

- Kits are being prepared for upcoming programs.
- Stem volunteers will be needed. Days and times will be determined.

CAC

- Ewa Bacon is serving on the Citizens Advisory Committee for 5 years. This is her third year. Her report follows.
- District 200 is planning a November 5 referendum. Money will be used for major updates at the middle schools.
- The committee is discussing the tax impact for residents. The district is asking for 151 million dollars.
