Lombard Lilac Days Craft Fair – Janet Miller

- Thank you to book donors and volunteers who made the May 4 Mini Book Sale a success.
- \$300 was raised from book sales, which more than covered the \$175 booth rental fee.
- Many flyers and bookmarks promoting our June Used Book Sale were distributed to attendees.
- At least 10 prospective members took AAUW membership information.

Manhattan Short Film Festival (MSFF) - Susan Peters

- We have a fundraising goal of selling 240 tickets for the Manhattan Short Film Festival on September 30, 2025 at the Glen Art Theater.
- 50% of Net Revenue from the film festival goes to the MSFF organization. Net Revenue is defined (by MSFF) as Total Revenues less Theater and Marquee Rental. Glen Art Theater receives only their rental fees and proceeds from concession sales.
- Cash/check ticket sales will be available at the May 31 luncheon, the June Used Book Sale, and branch book groups. Online ticket sales will soon be available through EventBrite, which assesses a service fee.
