OFFICER REPORTS:

Treasurer

No financial statements were presented. The Treasurer's report is deferred to the August board meeting.

Membership Vice President – Marie Corcoran

- There are 129 paid branch members. One additional returning member's pending payment will bring membership to 130. Annual dues are currently receivable from 20 members who are in their 3 month non-renewal grace period. The grace period ends September 30, 2025.
- Branch new member orientation meeting is tentatively scheduled for September 17. Information packets are being updated.

Program Vice President - Karen Schulz

- The Fall KICK-OFF Branch Meeting will be held September 3, 2025 at the Glen Ellyn Police Department. Dana Fanslow, director of the Nippersink Public Library District, is confirmed as guest speaker with topic pending. Gelato will be served. Please invite your friends; non-members welcome.
- Sarah Allen hosted a well-attended program planning meeting on July 22, 2025. In addition to the September KICK-OFF meeting, December, November, and February programming is now planned.

COMMITTEE REPORTS

STEM – Fran Kravitz

We have been contacted by the Glen Ellyn Public Library to present workshops for December, January, and February, meaning that we will have workshops from September 2025 through February 2026. Monthly workshops have been planned on exciting topics including magnetic fields, chemical batteries, tensegrity, kinetic energy, the science of bubbles, and Möbius strips.

Book Sale update – Ewa Bacon

- We collected 14,300 adult books and 5,500 childrens' books. 45 Branch members worked during the sale.
- According to sales tickets, we had 750 customers. There were 481 sales transactions on Thursday, 159 transactions on Friday and 110 transactions on Saturday.
- Gross sales proceeds were \$17,288, with net proceeds to be determined at a future date.
- Park View Elementary School was an excellent site. New features included puzzles and games, Saturday incentive pricing for multiple bags, and a checkout station reserved for large orders.
- A motion was made by Marie Corcoran to continue the existing Book Sale leadership of Nancy Possinger, Karen Schulz, and Ewa Bacon for the next sale tentatively scheduled in June 2026. The motion was seconded by Laurie Driscoll and unanimously approved.

MANHATTAN SHORT Film Festival (MSFF) – Susan Peters

- 69 tickets have been sold with two months to go for the screening on September 30, 2025 at the Glen Art Theater. Local signage will go up in mid-August. We will decide in 30-40 days if we need a second site.
- Members can buy their tickets at branch events to avoid EventBrite's \$3.52/ticket service charge.

Public Policy – Laurie Driscoll

- We have new AAUW state chairpersons.
- There will be a sign-up sheet at the September 3, 2025 Branch meeting to subscribe to public policy email notifications.

Fall Fundraiser Walk - Carolyn Oesterle

A 2 mile walk with coffee and refreshments is scheduled for October 24, 2025

- There was discussion of how to identify candidates for open committee chair positions (e.g., through new member orientation) as well as providing mentorship for new committee chairs.
